This Budget Change Request increases the capital improvement budget in the Utility Services Connection Fee Fund by \$488,684 for the North Merritt Island Zone E and South Merritt Island Zone R Force Main projects. The original scope of work changed to include the design of 1,778 linear feet of force main to connect to SOIRL North Merritt Zone E and 15,325 linear feet of force main to connect to South Merritt Zone R. This work will expand the service area and enable new connections to the system. The projects will be funded utilizing the Department's connection fees capital reserves.
