Requested Action:

It is requested that the Board of County Commissioners (1) approve the statement of legislative intent set forth below; (2) direct staff to prepare an ordinance amending Chapter 78, Article III, Section 78-82, "Parks and Recreation, Use of Parks, Permits" of the Brevard County Code of Ordinances; and (3) schedule and advertise the ordinance for public hearing.

Summary Explanation and Background:

Section 78-82 - Permits of the Code of Ordinances of Brevard County, Florida currently states, in pertinent part:

- (b) The [Parks and Recreation Department] shall issue a permit when all of the following conditions are met:
- (1) The desired park (or requested portion thereof), recreational facility, or department managed lands has not been reserved for other use at the time requested. ...

Statement of Legislative Intent: It is proposed that Section 78-82. - Permits of the Code of Ordinances of Brevard County, Florida be amended to include a provision limiting special event permits at Wickham Park to a maximum of fifteen consecutive days or two consecutive weekends (Friday - Sunday). For the public's enjoyment of Wickham Park beginning in 2025, January, February, March, and April will have one weekend per month without permitted Special Events.
