Marella Bay, Costa Vue, Addison Cove, Marina Isle

This is what they are calling all the large low income apartment complexes in Central Merritt Island. They have been recently taken over or bought, a very difficult trail of information to follow, by a large group from Lakewood, NJ called Opus Management. They have bought Courtenay Palms, Baxley Manor, Country Club Apartments and more. All zoned as "low income housing/apartments" per the Brevard County Public Appraiser site. While some residents may view this as a good thing assuming the properties will be cleaned up or crime may be decreased in those areas I would like to show a different perspective that is quickly becoming reality in Merritt Island.

We do have a wonderful Senior Resource in Brevard called Senior 202 Housing, it has a 5 year waiting list. It would be nice if someone could get the same kind of benefits in that program to apply to all senior citizens on fixed incomes no matter where they live. Rent is fixed and income based, utilities are covered, some even provide one meal and transportation. There are only 6 buildings in the county.

What Can You Do?

SPEAK UP! To anyone and everyone you know. It is my personal belief after reaching out to several local government people that this is a problem only Governor DeSantis can fix. Regardless of your party affiliation he is our current Governor and at the level to cut through red tape and get something done. These people cannot keep waiting, they are being evicted daily. There are 1502 units in these apartments combined. Imagine how many will be out on our streets over the next few months.
