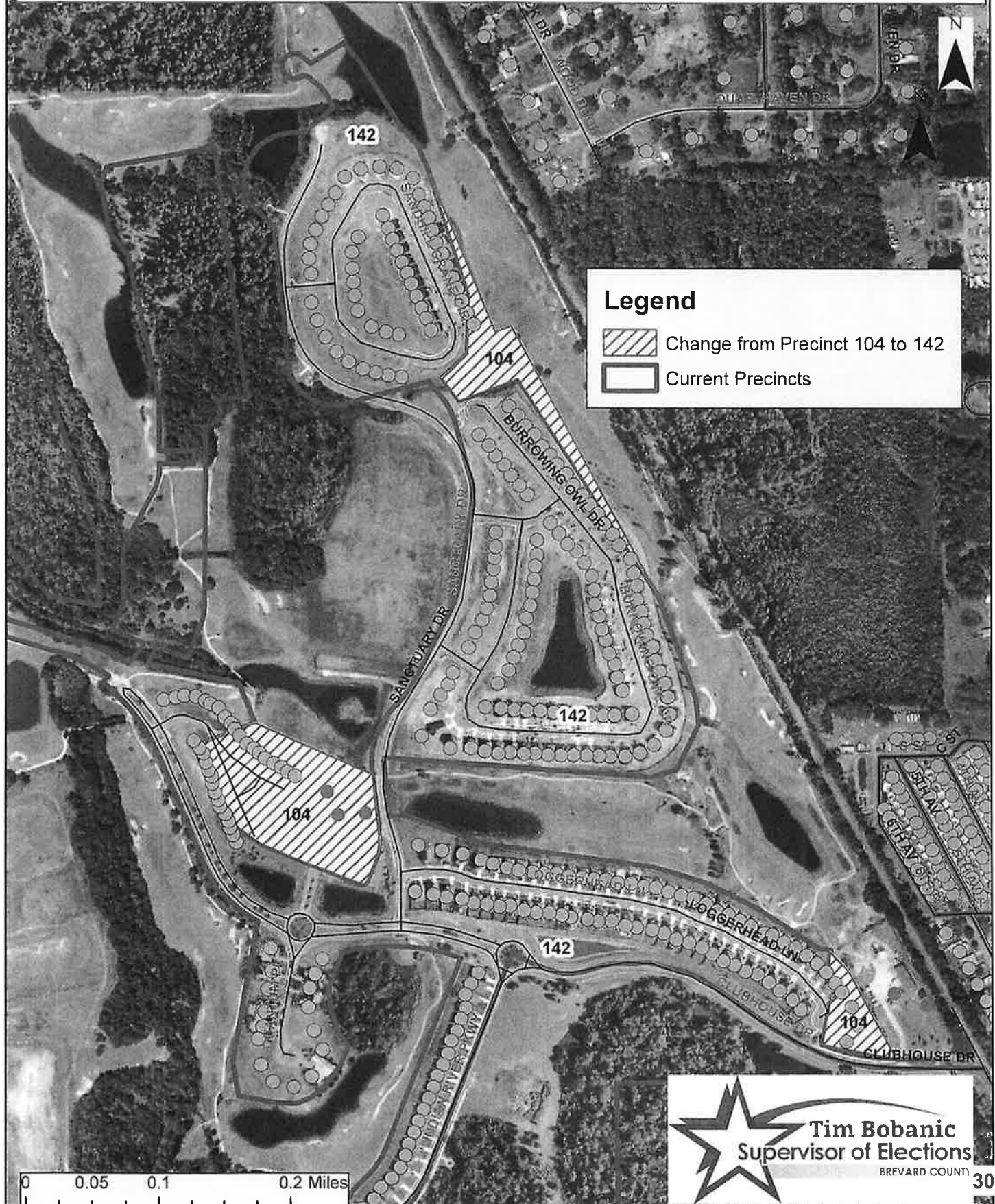

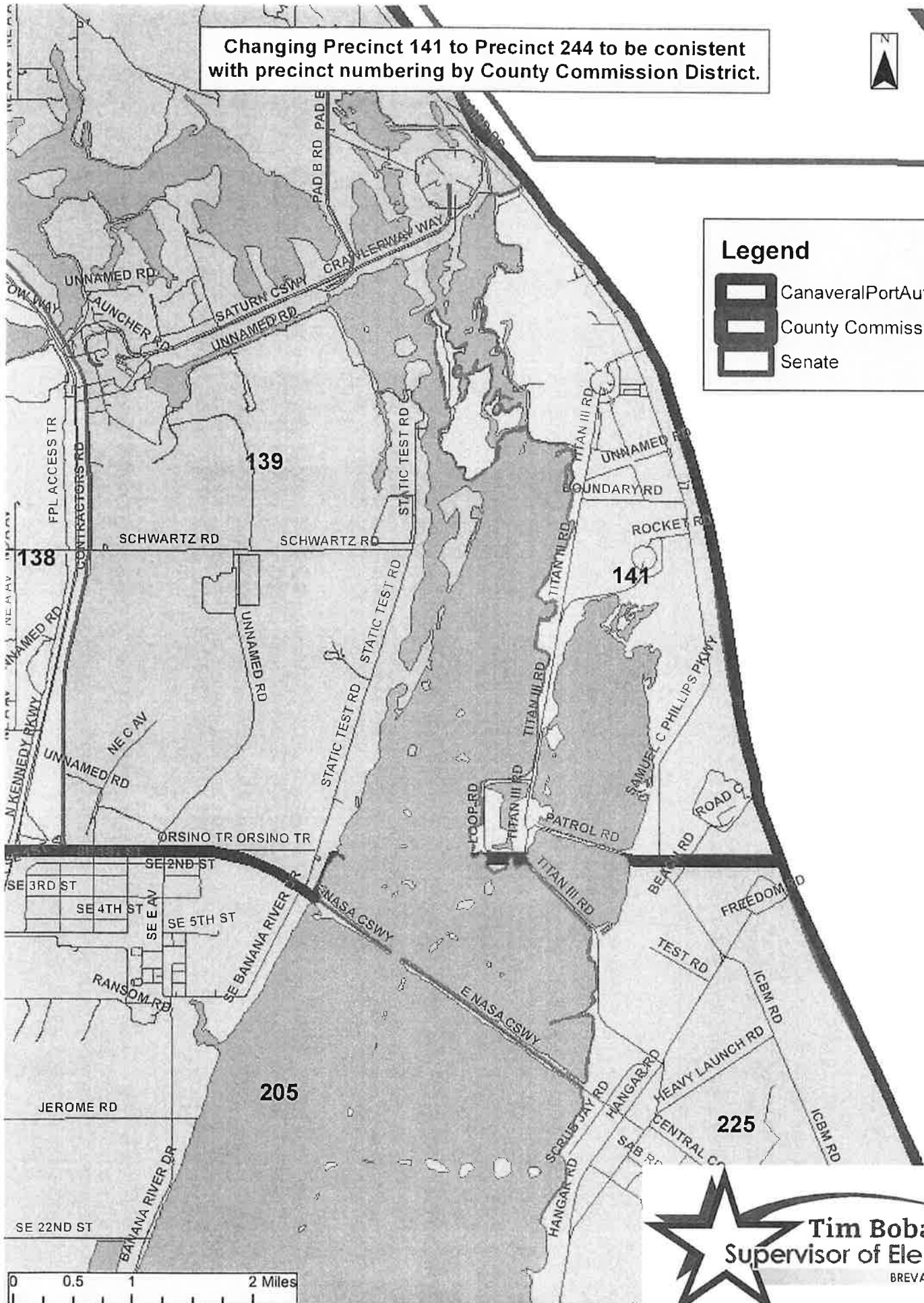



Changing Precinct 141 to Precinct 244 to be consistent with precinct numbering by County Commission District.
