
RE: Item I.3., Seeking Citizen Input Regarding an Elevated Boardwalk and Associated Amenities

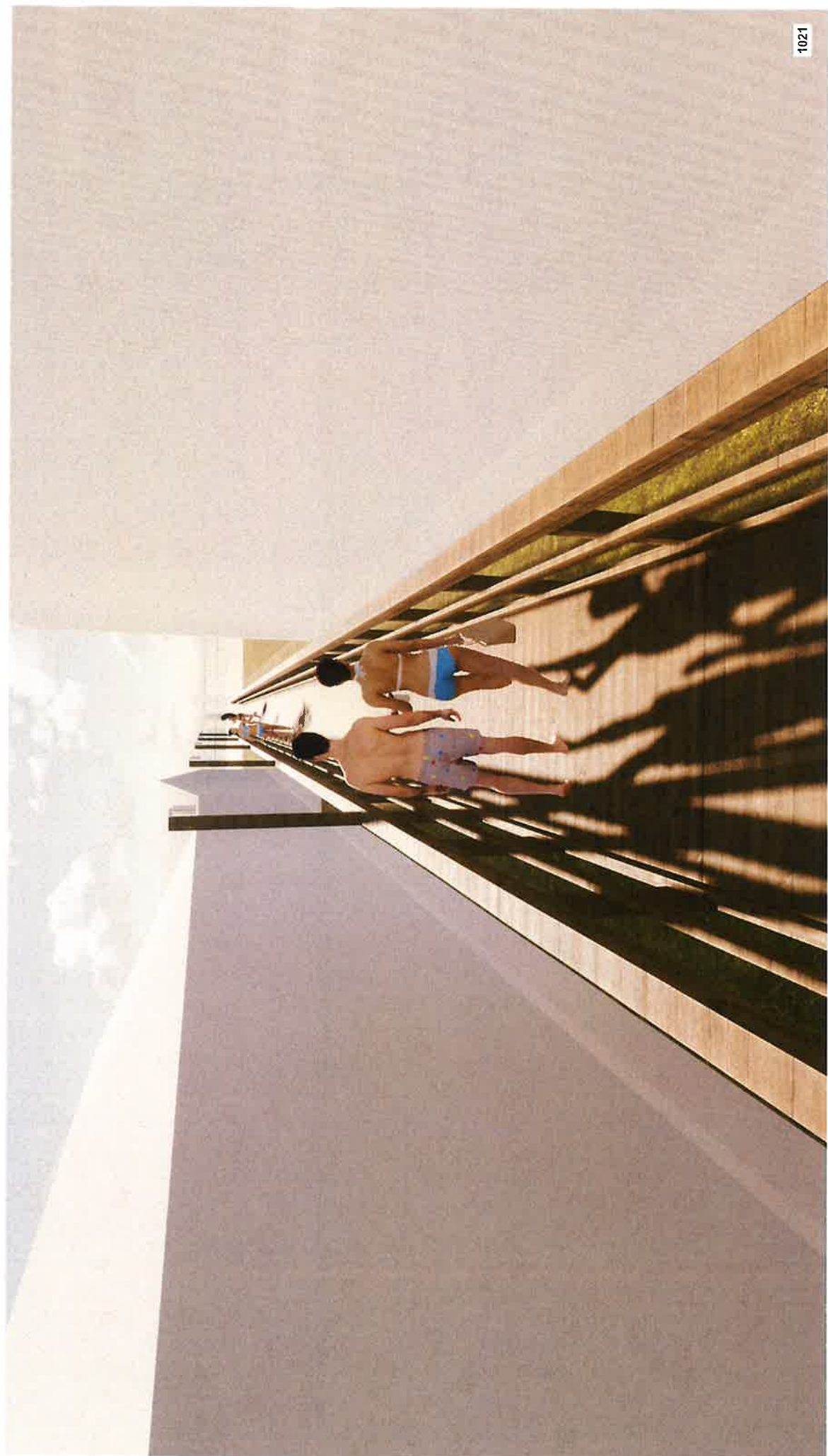

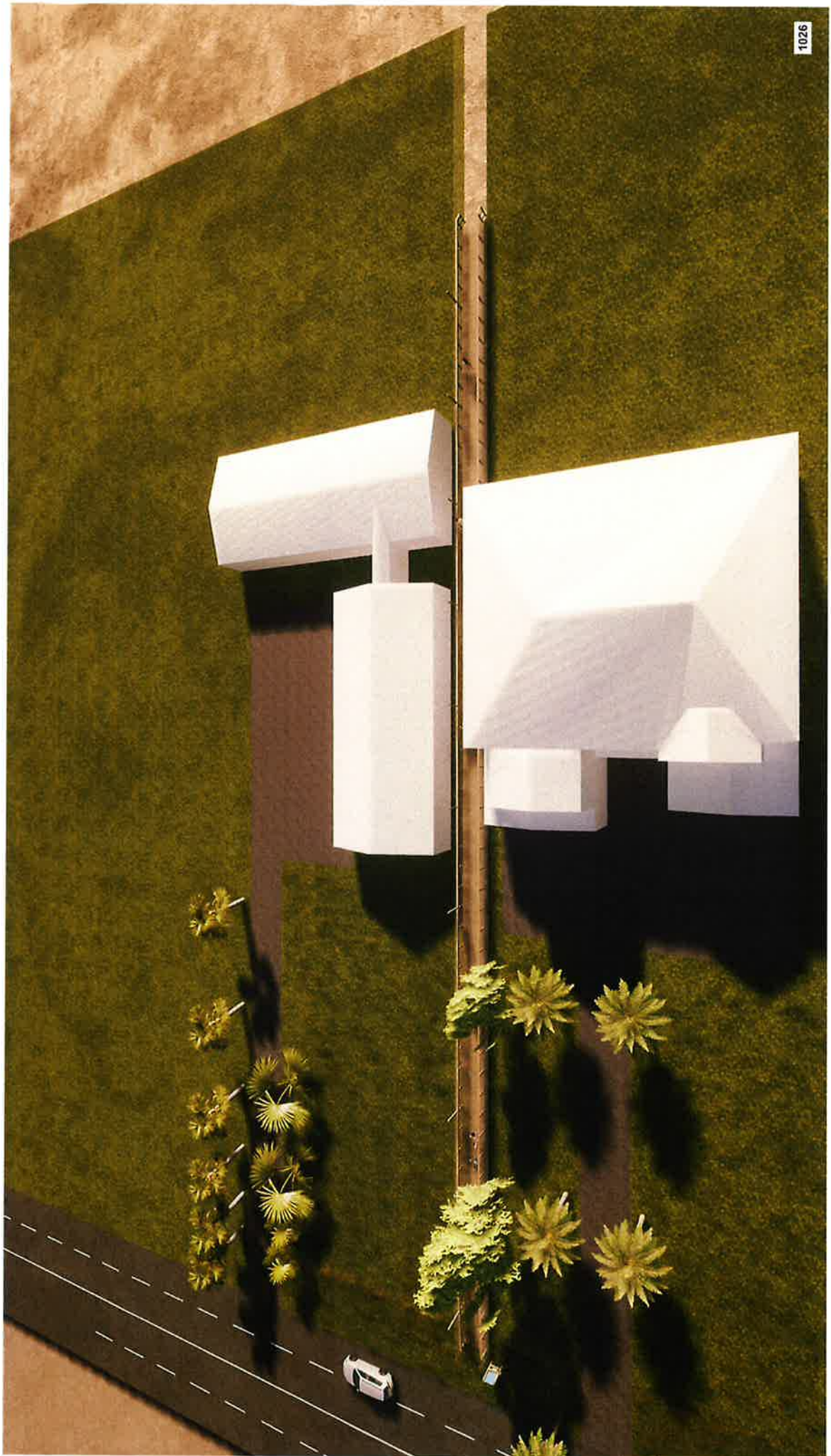














Motion Sheet

Item I.2 Lifeguards:

I move to:

1. Approve priorities 1-3 as written in the Brevard County Fire Rescue 2023 Ocean Rescue Assessment, and direct staff to move forward with tower upgrades as soon as possible.
 - a. Cost to achieve priorities will be funded by the County, reallocating from this year's budget, and making adjustments to the FY23-24 budget.
 - b. County funding for full-time Indialantic Boardwalk lifeguard tower to expire at the end of FY2022-23
 - c. Authorize the County Manager to make any necessary budget adjustments to accomplish any ocean lifeguard staffing modifications that the Board directs.
2. Direct staff to negotiate annual service contracts, as directed by the Board, with the City of Cocoa Beach, Town of Indialantic, and Town of Melbourne Beach, and any other municipalities, in which the Towns or City are billed at actual cost for parks maintained by the Town or City in which they are located.
 - a. Staff shall bring the negotiated agreements to the Brevard County Board of County Commissioners for approval within 60 days of close of negotiations.
3. If the cities object, staff will come back to the Board of County Commissioners for direction.
4. If the cities elect not to use lifeguard services by Brevard County, staff will readjust their extreme recruiting efforts accordingly.

Item I.3 Beach Access

I move to request approval for the District 3 office to send letters on behalf of the Board to the surrounding neighbors that are within a 500ft radius of the beach access located in Indialantic, across from Beach Street, and ask for input regarding improvements to the access.
