**AN ORDINANCE AMENDING CHAPTER TWO, ARTICLE VI, DIVISION FOUR, SECTION 2-213 OF THE CODE OF ORDINANCES OF BREVARD COUNTY FLORIDA, ADDING PROVISIONS FOR REMOVAL OF ADVISORY BOARD APPOINTEES; PROVIDING FOR TERM OF REPLACEMENT APPOINTEES AND ADDRESSING IMPACTS ON TERM LIMITS IN THE EVENT OF REMOVAL; PROVIDING FOR CONFLICTING PROVISIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AREA ENCOMPASSED; PROVIDING FOR AN EFFECTIVE DATE; PROVIDING FOR INCLUSION IN THE CODE OF ORDINANCES OF BREVARD COUNTY.**

Pursuant to Section 286.0105 Florida Statutes, if a person decides to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she will need to ensure that a verbatim record of the proceedings is made, at his or her own expense, which record includes the testimony and evidence upon which any such appeal is to be based.
