REQUESTED ACTION:

It is recommended that the Board of County Commissioners approve the attached resolutions adopting the final budgets for FY 2018-2019 for the County's dependent special districts, and authorize the Chair to sign said resolutions.

SUMMARY EXPLANATION and BACKGROUND:

Budget Office personnel will read into the record the resolutions adopting the budgets of the County's dependent special districts. For taxing authorities with dependent special districts, the Board may adopt budgets for all dependent special districts by a single vote unless separate votes are requested by a member of the public. 


